- Opening and Chalice Lighting: Linda called the regular Board Meeting to order at 5:07 p.m. PST by Zoom and lit a chalice.

- Send personal acknowledgments to first time Pledge Drive donors.

Engagement:

Minister's Report to the UUCOD Board

April 18, 2023 The Rev. Ian W. Riddell

Summary Outline of the work I've been involved with for the past month. This is not an exhaustive list but is meant to give you a general idea of what I've been up to as your minister.

A. Counseling and Pastoral Care

- The Care Team met for our regular meeting on Zoom this month.
- We continue to check in and share our contacts with congregants and offer each other guidance and support in our support of congregants' needs.
- I continue to meet with congregants in need of connection and conversation by phone and Zoom and in person.
- This month, I continued making phone calls with the goal of calling all members and friends for a pastoral check in in the next few months.

B. Administration, Governance, and Staff

- I continue to meet with the DIB Ministry team.
- I meet weekly with Pam Bibo to check in on work expectations and how things are going.
- Jeffrey Lesser continued to lead rehearsals with our choir through Wednesday, April 5. We
 decided that Easter Sunday, April 9, would be the choir's last singing performance this
 church year. I joined in their final rehearsal and led the choir at that service while Jeff
 accompanied. I will work with the Board and choir to make plans for filling our choir
 director position for the fall.
- The Committee on Ministry is working in teams on our upcoming offerings: "Living into Right Relations in our Congregation" [April 20 and 27 at 6:30pm on Zoom] and "Microaggressions and Loving Communication" [May 7 in person after Sunday service].

- I meet monthly with President Linda Savard and First Vice President Bill Masco to plan the agenda for the monthly Board meeting and coordinate on other issues.
- I met with our Safety Task Force to work through a safety checklist assessment provided by Church Mutual to determine areas we need to attend to In terms of physical safety. We will do a physical walk-through of the building this Thursday morning.
- I worked with Sue Caspari to update our reporting of copyrighted music use through our Christian Copyright Solutions account. We continue to do this quarterly.
- I participated in the Church Council meeting on April 8

C. Membership and Committees

- I met with the DIB Ministry team for our monthly meeting. We assessed our work for the past year and welcomed new member Steven Toporoff.
- I met with the Chalice Circle leaders. We began assessing the past year and beginning to imagine our work in the next church year.

D. Lifespan Faith-Development

• The second offering of my class on our Common Read, *Mistakes and Miracles* was poorly attended. Only 1 person came to the first and second offerings. I cancelled the third offering. I will work to find other ways to engage the congregation in this material over the coming months.

E. Worship

- We have service leaders planned through the end of June and the Worship Team and I
 have begun filling the calendar for the summer and early fall.
- I continue to lead the weekly Production meetings. In our production meetings, we continue the practice of reflecting on the service the day before and noting any issues we need to address.
- I led or participated in worship several times these past months:
- April 2—I Brought My Spirit to the Trees: Our Camp de Benneville Pines with the Peet Paduano family!
- April 9— Returning to Life (Easter) with Derek Moore as Worship Associate and our Choir
- April 16—Curioser and Curioser: Questions Newcomers As of Us with Ginger Hemingway as Worship Associate (Auction sermon topic)
- We continue to welcome guests and old friends to our pulpit: Rabbi Mark Borovitz and his wife, Harriet Rossetto (March 26).

F. Denominational Activities

- I regularly consult with local and regional colleagues on issues affecting our congregations.
- I continue meeting monthly as a mentor to a person in the ministerial formation process for feedback, support, and context setting as they move through the credentialing process.
- I attended the Spring retreat for the Pacific Southwest chapter of the UU Ministers Association. I serve our chapter as part of the nominating team.

f. Treasurer Jerry L'Hommedieu's Written Report:

UUCOD Treasurer's Report March 2023

As of March 31st, UUCOD held deposits of \$290,716.22 which includes \$150,907.03 invested with UUA in its UUCOD Investment Fund. Of the total amount, \$241,754.86 is held in either dedicated or restricted funds. This leaves \$48,961.36 in available, unrestricted funds.

Excluding changes in fund values, UUCOD's March revenues were \$16,427 and expenses were \$23,566, a deficit for the month of \$7,139. A successful yard sale brought in \$6,470; forty percent of total revenues. UUCOD collected \$365 for S.C.R.A.P.E. Galleries as part of March's Share the Plate and \$1,148 was collected in February for Safe Schools Desert Cities' scholarship fund. The only exceptional expenses were \$2,300 for tree trimming and Vanessa Ament's final paycheck which included accrued vacation time. Year to date, UUCOD has excess revenues of \$56,094.

At the March board meeting, the board approved a proposed budget of \$307,000 which will be submitted for approval by the congregation at the annual meeting on April 30. The budget includes \$35,000 from reserves for parking lot repair and approved work on Sacred Grounds. Leslie Gebhart led a workshop which brought in nearly \$4,000 for Sacred Grounds. The Sacred Grounds interest group is developing plans which initially include extending the patio and pouring new walkways in this fiscal year and additional planting of native plants in the fall. The group is initiating new fundraising to support these efforts.

The transition from TIAA to Empower as UUA's retirement program administrator continues and should be completed by mid-April.

The irrigation has been getting an update by Dave Emmerson (thank you).

There is much chysmus growing and we need a large weeding party. To be arranged later, with Sacred Grounds.

Within the building, we are needing to replace the door mechanisms for both the front door and the community room door. This will cost over \$3,000 each. (This amount is not the final price, but only mine, with no paperwork to look at).

Everything else seems to be working fine right now.

b. Sacred Grounds Initiative:

Sacred Grounds report to Board, April 18, 2023

Steering Committee

We have formed a Steering Committee. The intent is to provide a body for decision making (or making recommendations to the Board), coordinate communication, and keep projects moving. The members are Rod Belshee, Diana Leslie, Mel Wilkinsen (Facilities), John Ressler, Dave Emmerson, and Jack Fitzsimmons (starting in the Fall). We'd also like a member of the new Board.

The new Steering Committee will reexamine projects and priorities. In particular there will be a focus on planting season next October-November.

Phase One Projects

The Celebration Garden walkway design has continued to evolve. John now has a very attractive design, and he is engaged in deep conversations about materials to create something without maintenance issues. Gene Kain is very excited about the project and offering suggestions to John as well.

Our contractor has missed multiple dates for responses and bids. We are re-starting the process of engaging concrete contractors, which is quite disappointing. We hope to find one with experience in design projects, not just plain flatwork.

The new Steering Committee is questioning whether the patio expansion fits under the Sacred Grounds vision (the original impetus was a patio water feature and patio garden). Having spent \$13K of donation on the misters, there is a desire to focus more on the grounds and developing

native gardens. The patio concrete extension is a project that Facilities may wish to pursue. Similarly, the sidewalk through the Garden of Hope to Via Vail is also being questioned since we do not have nearly the same need for overflow parking on the street that we did when that project was first proposed.

The Steering Committee will be developing priorities and will present new direction to the Board.

Demonstration Garden

The heart of Sacred Grounds vision is providing native habitat. Three congregants (Mel, Dave E, Sue E) in the UCR California Naturalist class drew up concepts for our demonstration plant communities.

Their concept includes four different demonstration plant communities, each with small educational signage. We can have a demonstration of desert wash, blow sand, canyons, and stabilized sand. Each has its own plant species, pollinators, and critters. Species that are particularly attractive, such as chuparosa and desert lavender are being proposed to help balance the goal of native habitat with an attractive landscape. The hope of the three designers is to provide a demonstration that native landscaping can be attractive, and encourage homeowners and landscape designer to move to native species. Given the reduction of native habitat and climate change, these little refugia in our own yards may become critical habitat for our native species.

Our planting season is Oct-Nov so we will be focusing on what we can accomplish this fall.

c. Finance Committee Audit Subcommittee Report:

AUDIT COMMITTEE REPORT TO BOARD April 2023

This report is a follow-up to the report provided to the Board in Jan. Our plan continues to be to meet and review different areas of our procedures quarterly. Our objective remains to review our procedures and where there is a finding in the application of the procedures (our practices), we will develop a corrective action plan. This will be done at the completion of our audit. We are using a format from the UUA website. Our first session was a review of our procedures in the Income area.

The audit committee met in March for our 2nd review of the procedures for expenses (specifically the Authorizations for Expenditures). Our next meeting is scheduled for September.

The sale was held for two days this year, rather than one day as in previous years. It was found that the amount of items donated could not be sold in one day, necessitating them to essentially be given away. Two days proved to be a good decision as multitudes of wonderful items were donated again this year, even more than in 2022.

However, holding the sale for two days also cause a dilemma- how to safely store the sale items the nights of 3/17 and 3/18. The suggestion of volunteers taking turns watching the items throughout the night was not used. The committee was afraid for the safety of these volunteers. Instead, volunteers were recruited to pack up items and move the tables inside the church. This necessitated taking the tables out again Saturday Morning and once again arranging items on the table. At the end of the sale on Saturday the 18th, volunteers packed up what remained and took it to the Community Room to be available to people after Sunday Service.

Advertising:

The sale was advertised in Tidbits magazine, Desert Sun Paper, Facebook for the public and Facebook UUCOD Community page, Market place, Craigs list, NextDoor.com, PostMYGargaeSale.co, (which posts to Gsalr.com, Yardsalesearch.com,

Garagesalefinder.com, Yardsales.net, Garagesalestracker.com). Street signs were placed at important locations both days of the sale.

Donation of remaining items after sale.

Many charitable organizations are no longer picking up items after sales. Those that do, will not pick up later in the afternoon. Galilee Center was available for morning pick up on Monday 3/20.

Some after thoughts from the committee are:

- Ask for use of a vacant building for a week for set up and sale. Community Room is too small. Must keep Church doors locked during the sale which is impractical. Have to haul items in at night, take out in the morning which is too labor intensive.
- Alternate solutions to safely storing items overnight if another location is not found might be, hiring a security guard or organize an overnight party for congregants in the parking lot.
- No Sunday sale after Service, it is too labor intensive for a small return.
- Hold sale on Thursday & Friday (best days for sales) in March before snowbirds leave.
- Advertising was great, it paid off.
- Consider starting sale earlier in day, possibly 7 am. End earlier in afternoon.
- Ask that donated items be cleaned first. Pricing volunteers had to spend too much time cleaning donated items.
- Include a card with what the Unitarian Universalist Church IS with the business card. Such as: 'The Unitarian Universalist Church is a theologically liberal religion characterized by a "free and responsible search for truth and meaning" and a belief in the inherent worth and dignity of everyone. UU's do not share a creed rather, they are unified by their shared search for spiritual growth and by the understanding that an individual's theology is a result of that search and not a result of obedience to an authoritarian requirement. UU's draw on many different theological sources and have a wide range of beliefs and practices." Learn more at uua.org. Shoppers asked.

Additional information from Jane to Linda in an email: Presuming the Board would like a Yard Sale next year, who would be Chair of running it? I have not been approached about it, but if I were, I wouldd have to think about it. Whoever does run it, cannot do it alone. There were three of us this year and I think that is a good number. We each took a part - Janice did the advertising- Marilyn did signage- and I did general organization

and recruited volunteers. We met regularly, starting in November. I started in September. Worked well! So, I suggest something similar in the future.
