## **MINUTES**

- 1. Opening and Chalice Lighting: Linda called the Church Council to order at 9:05 a.m. PST, and Rev. Riddell lit the chalice and gave an inspirational reading.
- 2. Check-Ins: Bill led a check-in of everyone.
- 3. Pledging and 2023–2024 Budget: Jerry explained the kick-off and plans for the upcoming pledge drive. Jerry anticipated questions concerning why the pledge drive goal has increased, and he explained diminished income and increased expenses from last year's budget. He also encouraged today's participants to complete their pledges by next week so that church leadership pledges' can be announced with introduction of the pledge drive. Jerry gave an overview of the status of planning and finalizing next year's budget.
- 4. Spiritual Leadership: For the Nominating/Leadership Development Committee, Jane and Walter advised of their work on proposing planned spiritual leadership education for the next year. They summarized their participation in the suggested training course "Claiming Our Spiritual Leadership," and highlighted the course's main concepts.
- <u>5. UUA Article II Revisions</u>: Rev. Riddell went over proposed revisions to Article II of the UUA bylaws concerning covenanted principles and purposes, which were last

substantially revised in 1985. Specifically, he went over the UUA's Article II Study Report 2021–2023 prepared by the UUA's Article II Study Commission which the UUA launched in 2020. Participants listened to Rev. Riddell's summary and agreed to consider the proposals.
